Terms of Agreement

- 1. I understand that I am enrolling my child for the dates selected on the Fee Schedule, during the summer of 2017 (June 5 August 18, 2017; excluding July 4, 2017). I understand that the program serves participants beginning at 7:00 am and closes at 5:30 pm on NON-Summer School Days (Weeks 1, 5 and 8-11) and begins at 12:00 pm and closes at 5:30 pm on Summer School Days (Weeks 2-4 and 6-7). It is essential for me to pick up and drop off my child during this time. Parents whose children remain past 5:30 pm must pay overtime fees as follows: 5-15 minutes overtime \$5.00 per child and each additional 1-15 minutes \$5.00 per child. Late fees must be paid upon picking your child(ren) up.
- 2. Due to the seasonal nature of summer camp and the set limitation on spaces offered, no refund shall be provided for absences, changes, withdrawal, or dismissal for cause. I understand that in the event of any absences during program hours, activities, I will be responsible for fees during time reserved, not actual time spent in the program. I will give 30 days notice in writing, prior to withdrawal from the program, during which time I will be responsible for payment of fees.
- 3. I will update my child's file information as changes occur in emergency contacts, medical information, change of personal information (address, home, cellular or work phone), etc.
- 4. I understand that Deerfield Community Center cannot serve children who display chronically disruptive behavior. Chronically disruptive behavior is defined as verbal or physical activity which may include but is not limited to such behavior that: requires constant attention from the staff, inflicts physical or emotional harm on other children, abuses the staff, ignores or disobeys the rules which guide behavior during the program time. For the safety and general welfare of all campers, the Camp reserves the unrestricted right to dismiss a camper whose conduct or influence, in the opinion of the director, is detrimental to the best interests of the Camp.
- 5. In the event that family, guardians, emergency contacts and family physician cannot be reached immediately, I hereby grant permission for emergency medical care or treatment. If the emergency is such that immediate hospital attention is necessary, an ambulance or emergency vehicle may take my child to the hospital. Furthermore, I hereby give permission to such hospital or outside doctor to authorize x-rays and emergency treatment if deemed necessary. I understand that all medical bills for service rendered are my responsibility.
- 6. Permission is hereby granted to Deerfield Community Center to take my child on trips outside camp as part of the regular camp program. I give permission for my child to participate in both transported and walking field trips and other activities during operating hours.

- 7. I understand that my child's camp tuition must be paid in a timely manner. There will be no refund of tuition for any days that a child misses due to illness, or vacation.
- 8. ASSUMPTION OF RISK AND HOLD HARMLESS AGREEMENT. Our camp takes place both indoors and outdoors and includes activities which are adventurous and challenging. All camp activities contain certain inherent risks. Our purpose for this disclosure is not to cause you undo concern but to inform you of the risks connected with the fun, adventure and challenge of all camp programs. You as a parent/guardian of your child(ren) are aware of the inherent risks of injury, death and property damage involved in camp activities including but not limited to swimming, canoeing, hiking, trampoline, nature activities, playgrounds, sports, etc. You as parent/guardian shall indemnify, defend and hold harmless Deerfield Community Center and its officers, directors, shareholders, employees, agents, owners of property used/leased by Deerfield Community Center and representatives (collectively) against all liability demands, claims, costs, losses, damages, recoveries, settlements incurred by indemnities ("losses") regardless of cause other than gross negligence, known or unknown, arising from your child(ren)'s participation in Deerfield Community Center Day Camp activities.

This contract constitutes the full understanding of the parties hereto and no change, modification or waiver of any of the term shall be effective unless in writing and signed by both parties.

I have read, understand, and agree to comply with the "Terms of Agreement" as stated above, and give my child permission to participate fully in this program.
